

## **LINCOLN COUNTY 4-H SELF-DETERMINED BOOSTER SCHOLARSHIP**

The purpose of this scholarship is to allow clubs and/or individuals to:

1. Attend programs where costs might be prohibitive
2. Travel to 4-H events that will require additional funding
3. Travel to a self-determined location for the purpose of furthering the education of the club member(s) and promoting 4-H ideals

### **GUIDELINES FOR SCHOLARSHIP SELECTION:**

1. Applicants are limited to 4-H Clubs and/or individual members who are currently active in Lincoln County. All members (adult and youth) planning to participate must be registered in the 4-H 2.0 system currently supervised by the 4-H Kansas Foundation.

Transfer 4-Hers meeting these requirements will be accepted.

2. 4-H Clubs and/or members interested in applying for the Self-Determined Booster Scholarship should complete the following:
  - a. Form which is to be typed.
  - b. A detailed presentation of why the applicant would like to attend and what benefit will be attained.
  - c. May be asked to complete a personal interview by the scholarship committee.
3. The form and presentation are due in the office **no later than 30 days prior to the date of the event.**
4. The screening committee will be made up of 4-H Booster volunteers.
5. The above rules are subject to change with a majority vote of the Lincoln County 4-H Program Development Committee.
